ALTERNATIVES MAINTAINED AN ONGOING CASELOAD OF 2,750 PARTICIPANTS. AS A PROGRAM, CARE COORDINATION ASSISTED 95% OF SENIORS ELIGIBLE FOR NURSING HOME CARE TO REMAIN IN THEIR HOME. 94% OF PARTICIPANTS AND CAREGIVERS INDICATE THEY WOULD RECOMMEND ALTERNATIVES' SERVICES TO OTHERS.
